



**BAC Resolution Declaring 1<sup>ST</sup> Failure of Bidding;  
And Recommending Approval**

**Resolution No. 2018-015**

**WHEREAS**, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the G-EPS and PAGASA Bulletin board continuously for 7 days from **11 to 18 June 2018**, and **in the newspaper of nationwide circulation on 12 June 2018**, the procurement of the following goods/items described hereunder, with its corresponding Approved Budget for Contract (ABC), under the reference, **P.R. No. 2018-04-0262 / IB No. 2018-008** to wit:

- to **RECOMMEND**, finally, the **APPROVAL** of aforementioned finding and recommendations.
