**WHEREAS**, the Philippine Atmospheric, Geophysical and Astronomical Services Administration (PAGASA), through the PAGASA Bids and Awards Committee, advertised the Invitation to Bid (IB) at the PAGASA website, the G-EPS and PAGASA Bulletin board continuously for 7 days from **13 to 20 November 2018**, the procurement of the following goods/items described hereunder, with its corresponding Approved Budget for Contract (ABC), under the reference, P.R. No. 2018-09-0718 / IB No. 2018-020 to wit:
